Notes to applicants

When can ATC be considered?

- ATC will be available only to doctors who have successfully completed at least one year in their original speciality training post or GP post, obtaining Annual Review of Competence Progression 1 (ARCP1 or 7.1)
- ATC may apply to competences achieved during Locum Appointment for Training (LAT) and Fixed Term Specialty Training Appointment (FTSTA) posts provided recruitment, selection, training and the ARCP process meets the requirements of the GMC approved CCT programme. Elements for accreditation from LAT or FTSTA posts should come from only one training programme (accreditation may not be accumulated by gaining competences related to two or three or more different training programmes)
- ATC will not apply to competences achieved in Locum Appointments for Service (LAS)
- ATC will only apply to training acquired within a maximum period of five years leading up to this application for ATC

What does ATC allow?

- Entry into year 1 ACCS with reduction in the total time required in training in programme (e.g. if run through training, reduction from total of six to five years)
- Entry of the trainee into ACCS year 2 or 3 of training
- Accreditation for areas of training that will not need to be repeated in ACCS
- ATC is expected to allow accreditation equivalent to a total training period of one year.

Are there any restrictions?

- ATC should be prospectively approved
- ATC will be allowed after successful competitive entry into ACCS programme
- ATC should be agreed either before entry or within 3 months of entry into the new speciality. Confirmation of progress against this agreement will be made at the first ACCS ARCP
- A doctor may apply for ATC once.
- All examinations required by the EM ACCS curriculum must be completed successfully to allow progress through programme
