

RCEM ACP Curriculum 2022 – Transition Principles

The 2022 ACP curriculum will be launched in September 2022. This reflects the Medical EM curriculum in embracing the specialty learning outcomes (SLOs) and entrustment decisions.

The majority of ACPs currently working towards credentialing should consider switching to the new curriculum (the ePortfolio will remain on the Kaizen platform but will look and function differently for those on the new curriculum). This document briefly summarises how you might make your decision

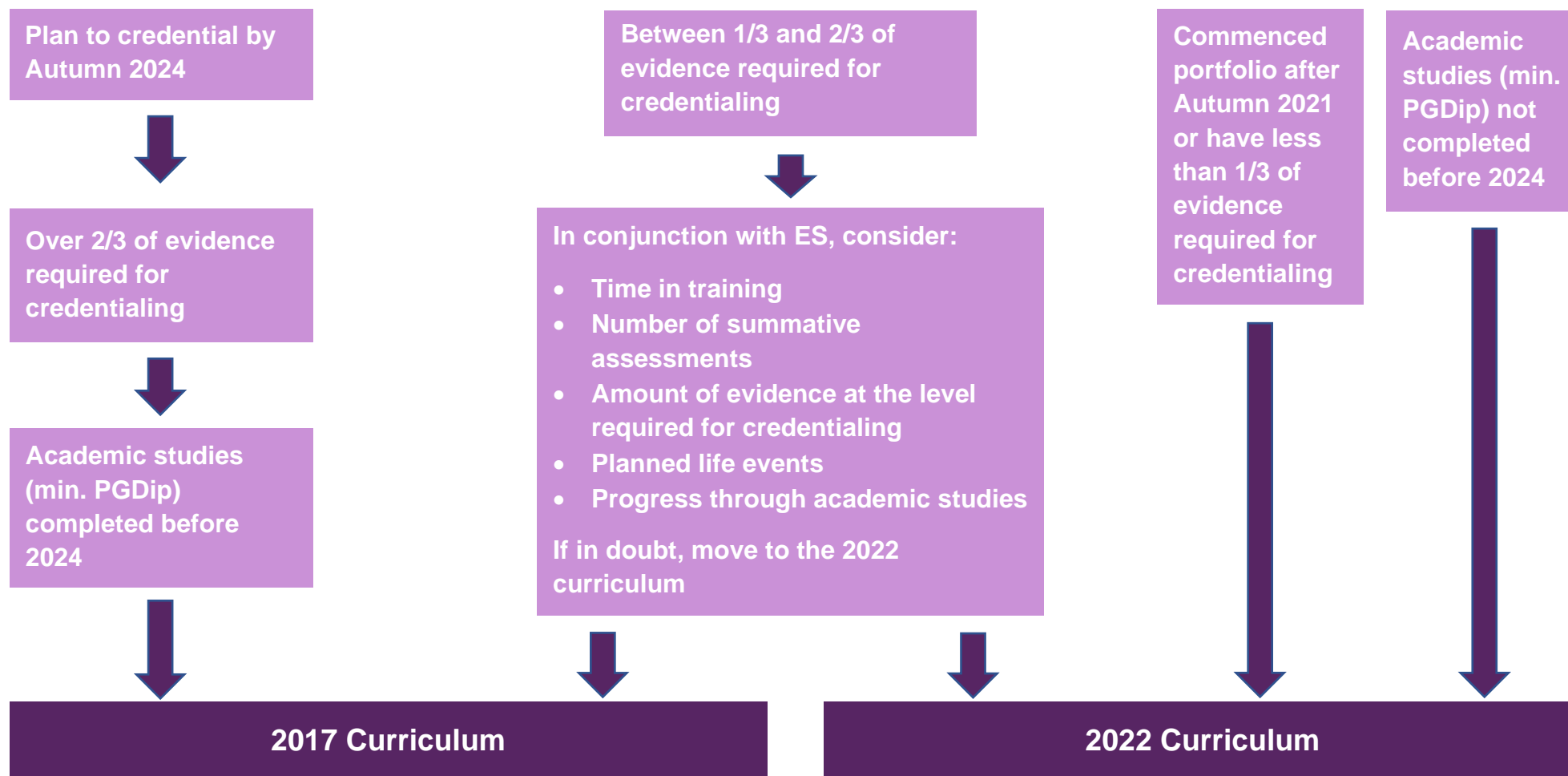

1. ACPs who have been collecting evidence for credentialing for more than 18 months and have accumulated a considerable volume of evidence within the Kaizen portfolio should aim to complete by Autumn 2024. In general, if approx. 60% or more of the presentations have evidence it would be advisable to stay on the 2017 curriculum. The current credentialing checklist will remain applicable.
2. ACPs who will begin to collect evidence for credentialing after August 2022 must be on the new curriculum and new portfolio. ACPs will be assessed against a revised checklist, SLOs and entrustment levels. ACPs who register for an ePortfolio account after September 2022 will automatically be placed on the new curriculum.
3. ACPs who began collecting evidence for credentialing between September 2021 and August 2022 must move to the new curriculum regardless of their experience and volume of evidence. ACPs will be assessed against a revised checklist, SLOs and entrustment levels. There is an advantage in transitioning as soon as possible.
4. ACPs who have been collecting evidence for credentialing for approx. 12 to 18 months and, consequently, have limited evidence within their portfolio, should strongly consider switching to the new curriculum. ACPs will be assessed against a revised checklist, SLOs and entrustment levels. There is an advantage in transitioning as soon as possible.

For those ACPs transitioning to the 2022 ACP curriculum, some existing evidence will be accepted for credentialing, such as evidence of post-graduate teaching, independent self-directed learning, and formal study courses. Some existing WPBAs may also be eligible to be used as credentialing evidence for the mandated elements.

Further information regarding mapping existing forms to the new SLOs will be published after September 2022.

Transition Decision Aid



It is strongly recommended that most trainee EM-ACPs should move to the 2022 curriculum as this provides future-proofing. There will be NO special circumstances which will allow for credentialing on the 2017 curriculum after Autumn 2024 (Spring 2025 for limited resubmissions).
