RCEMLearning ACP Supervisor Training (2022 curriculum)

The RCEMLearning ACP Supervisor training module is intended for Educational Supervisors of ACPs who will be credentialing on the 2022 ACP curriculum. It has been designed to give context to the new curriculum and provide guidance on how it should be applied in practice and to the supervision of ACPs on the credentialing pathway. This training module should therefore be completed in conjunction with reading both the curriculum document and credentialing regulations which provide detailed information regarding the standard and evidence required for credentialing. These documents are available to download from the RCEM website.

The learning session consists of seven short videos (modules) which were recorded during a 'live' virtual training session, and a series of multiple-choice questions (MCQs) to embed the learning. Within 10 working days of successful completion of this training (a minimum pass mark of 50% for the MCQs is required), the role of ACP Educational Supervisor will be assigned to your ePortfolio account which will enable you to complete the Foundation Skills Sign-off form, ESR, FEGS, and final sign-off of the portfolio prior to submission. The ACP must also add you to their portfolio as their ACP Educational Supervisor to provide you with access to their portfolio.

Completing the training

Please allow up to 10 working days following successful completion of the training for the ACP ES role to be assigned to your account.

Please note: if you have not previously completed RCEM ACP Supervisor training for the 2017 curriculum, or you completed it more than 3 years ago, we strongly recommend that you attend one of the 'live' sessions as they will provide an opportunity for you to ask questions of the faculty and request additional clarification on areas that you are unsure of.
