

# Regional Holding Centres for Category C Antidotes

## 1. Category C Antidotes

Use of these antidotes should always be discussed with NPIS and/or a Clinical Toxicologist who will be able to provide contact details to arrange the supply of these antidotes.

[Botulinum Antitoxin](#) and [Pralidoxime](#) are available free of charge through separate holding centres overseen by the UK Health Security Agency (HSA).

The remaining four Category C drugs are held within the 8 holding sites in England [at some sites Unithiol may only be available in the injectable form]; there are separate arrangements in Scotland (see below).

## 1. The Holding Sites

The 8 holding centres for Category C antidotes in England are shown on the map overleaf. The map indicates the anticipated geography that each holding site covers, but these boundaries are indicative only and a degree of flexibility is envisaged depending on the circumstances of any request.

In Scotland, Category C antidotes are available via the Rarely Used Urgent Medicines (RUUM) arrangements; details of holding sites can be found on TOXBASE.

## 2. The Process

Clinicians who have a patient who requires treatment with a Category C antidote should contact NPIS or a Consultant Clinical Toxicologist. Hospitals making a request to a Category C holding site in England before discussing the case with NPIS or a consultant toxicologist will be asked to contact NPIS for approval of use of a Category C antidote.

The pharmacy at the requesting hospital will then make contact with the pharmacy at the Category C holding site to arrange transfer of stock. The holding site will arrange transportation and it is recommended that antidotes will be available at the patient bedside within 4 hours of the request.
