**Role purpose**: RCEM is looking for an outstanding chairperson to lead the Safer Care Sub-Committee, a key strategic part of the Quality in Emergency Care cluster. The Chair will chair committee meetings, coordinate the work of the Safer Care Committee, Safety Flashes, and Safety

Newsletters, and ensure the College is appropriately represented on national bodies that relate to safety.

This is an honorary post and while no financial honorarium is offered for the post holder, the College will reimburse all post-related expenses (e.g. travel to meetings).

**Key working relationships**: The Chair will work closely with the Co-Chairs of the Quality in Emergency Care Committee, and other committees within the cluster, as well as members of the Safer Care Committee. The Committee Chair will be a member of the Quality in Emergency Care

Committee and is expected to attend these meetings which occur four times a year. The Chair will also work closely with the RCEM Clinical Quality Manager and other staff in the Clinical Quality Team.

## **Committee remit:**

- To develop and review safety guidelines, safety flashes, and safety snippets for the speciality of Emergency Medicine
- To develop Consensus Based Safety Statements for the speciality of safety in Emergency Departments
- To develop and maintain relationships with external safety bodies including NHS England, HSSIB, and the CQC.

- To develop and disseminate patient safety strategies for the speciality of Emergency Medicine
- To develop and maintain the Safety section of the Royal College website

#### **Role requirements:**

This role will be for three years, potentially renewable for a further three years. In this role you will be expected to attend four committee meetings a year, three virtual and one in person at RCEM's offices in London Bridge. You will also attend quarterly Quality in Emergency Care meetings and at times, attend other meetings to represent the College. Other business will be conducted by ad-hoc virtual meetings and via e-mail.
